



HIRE PERIODS:

- E-Bikes are to be collected from The Duver Hire Co, PO33 1YB, unless delivery has been pre-arranged.
- Minimum Hire cost is a Full Day Hire
- Full Day hires are 8 hours in duration (9am to 5pm).
- Where consecutive days have been booked, the hire period finishes at 5pm on the final day of hire.
- E-Bikes must be returned by 5pm, unless otherwise agreed. Late return may incur an additional charge.

CONDITIONS OF HIRE: The Duver Hire Co – The Hirer : The Client – You – The Hiree

1. E-Bikes and associated cycling equipment can only be hired from The Duver Hire Co upon the signed completion of a group booking form. This form must be signed by all cyclists in the group over the age of 18. Parents and Guardians will be requested to sign on behalf of those under the age of 18.
2. The lead Hiree must be over the age of 18.
3. E-Bike Hire minimum age is 14.
4. Proof of ID is required to secure a booking (Driving License, Passport). This ID will be copied and safely stored for the duration of the hire, and until the return of the equipment in a satisfactory and undamaged condition.
5. Please cycle sensibly, with respect for others and the natural habitat. Cyclists are expected to follow the Highway Code, in particular the “Extra rules for Cyclists” – Rules 59 to 82..
6. Equipment that is booked and paid for in advance is guaranteed.
7. Cycle helmets are provided for your safety and must be worn.
8. Anyone cycling in a discourteous or unsafe manner while in possession of The Duver Hire Co equipment will have the equipment repossessed with no refund of hire charges.
9. The Hiree must not operate the E-Bike whilst under the influence of drink or drugs. The Duver Hire Co reserves the right to refuse hire to any Hiree deemed unable to ride the equipment safely.
10. **E-Bikes must not be taken onto the beach or in the sea. E-Bikes will be damaged by salt water and sand. E-Bikes must also not be ridden through any rivers / flood waters or deep puddles. The Hiree will be liable for a compensation charge of £250 per bicycle if found to have been using the E-Bike in breach of these rules.**
11. As the Hiree, you understand that any cycling activity involves an element of risk. You are advised that any person using The Duver Hire Co equipment does so entirely at their own risk. The Duver Hire Co does not accept any liability for personal injury, loss or damage of property beyond its legal obligations.
12. **Bikes should be locked to a permanent fixture whenever they are left unattended. The method of securing should include the front wheel and the frame. Theft of an unlocked bicycle will be the responsibility of the Hiree who will be subject to £250 charge per bicycle to cover the replacement of the bicycle and it’s accessories.**
13. The bikes should be returned to The Duver Hire Co in the same condition as when given to the Hiree, except for ordinary wear and tear. The Hiree is responsible for any damage caused to the bikes and associated equipment, including helmets and locks, during the rental period.
14. The Duver Hire Co reserves the right to charge an additional fee for late returns.
15. Cycle hire can be cancelled up to 24 hours in advance for a full refund.
